

RESOLUTION NO. 16-28,902

A RESOLUTION OF THE COUNCIL OF THE CITY OF BURBANK, CALIFORNIA, RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION CONSOLIDATED WITH STATEWIDE GENERAL ELECTION HELD IN SAID CITY ON NOVEMBER 8, 2016, DECLARING THE RESULTS THEREOF AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a Special Municipal Election was consolidated with the Statewide General Election held and conducted in the City of Burbank, California, on Tuesday, November 8, 2016, as required by law; and

WHEREAS, the City Council of the City of Burbank, California, by Ordinance No. 16-3,884 and Resolution No. 16-28,873, adopted on August 1, 2016, did cause to be Noticed to the qualified electors of the City, a Special Municipal Election to be held in the City of Burbank on the 8th day of November, 2016, for the purpose of a ballot measure as follows:

Shall Ordinance No. 16-3,882 be approved allowing no more than a 14-gate, 355,000 square foot replacement terminal and ancillary improvements to be built at the Bob Hope Airport meeting current safety, seismic standards and improving disabled access; demolishing the existing terminal; and modifying Adjacent Property easement and authorizing future agreements necessary to implement the project; in exchange for governance changes that provide Burbank a greater voice in the future of the airport? WHEREAS, the notice of the election was given in time, form and manner as prescribed by law; the voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Burbank Charter, Municipal Code and where applicable Elections Code of the State of California, for the holding of elections; and

WHEREAS, the City's vendor, the Registrar of Voters of the County of Los Angeles, has canvassed the returns of the election and has certified the results as attached hereto made a part hereof as "Attachment A."

THE CITY COUNCIL OF THE CITY OF BURBANK RESOLVES:

Section 1. That the whole number of registered voters in the City was 64,832, making a total of 48,388 ballots cast in the City.

Section 2. That the ballot measure was presented as “Burbank City Special Municipal Election - Measure B.”

Section 3. That based on the 64,832 eligible Burbank registered voters, a total of 48,388 votes were cast, received and canvassed as required by law. The votes cast represent a 74.6% percent voter turnout rate. Of those ballots cast 29,587 were cast for “Yes” in favor of Ballot Measure B and 12,876 were cast for “No,” in opposition of Ballot Measure B.

That the number of votes given at each precinct and the number of votes given in the City to the measure are listed in “Attachment A.”

Section 4. The City Council does declare and determine that Measure B allowing no more than a 14-gate, 355,000 square foot replacement terminal and ancillary improvements to be built at the Bob Hope Airport has passed.

Section 5. The City Clerk shall enter on the records of the City Council of the City of Burbank, a statement of the results of said election, showing:

1. The whole number of votes cast in the City.
2. The measures voted upon.
3. The number of votes given at each precinct for and against each measure.
4. The number of votes given in the city for and against each measure.

Section 6. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
