SUSTAINABLE BURBANK COMMISSION November 14, 2022 MINUTES

I. CALL TO ORDER

The meeting of the Sustainable Burbank Commission was held in the Burbank Recycle Center Conference Room, 500 South Flower Street, on the above date. Chair Robin Gemmill called the meeting to order at 5:00 p.m.

A. Public Communication

David Eisenberg, Chair of the Verdugo Hills Group - Sierra Club, expressed concern about the Brace Canyon Park turf project.

Dianne Wolke expressed her concerns with the PFAS chemicals in artificial turf in the Brace Canyon Park project and concerns about requiring in-person meetings.

B. Commission Member Communication

Victoria Kirschenbaum attended the hearing of the Parks and Recreation Board and watched the Burbank Water and Power Board meeting regarding their sustainability efforts.

Alissandra Valdez announced the native planting at the Community Garden on November 19, 2022, and noted that CicLAvia will occur on December 4, 2022, in South Los Angeles. Ms. Valdez also announced she applied to a leadership development academy for youth regarding climate activism and encourages others to apply.

Jean Schanberger also attended the hearing of the Parks and Recreation Board and watched the Burbank Water and Power Board meeting regarding their sustainability efforts. Ms. Schanberger also attended a continuing education program on PFAS.

Robin Gemmill thanked Public Works for supporting efforts at the Community Garden.

C. Staff Communication

Ken Berkman announced that the Library Department is soliciting input on the proposed Burbank Civic Center project, which includes the Central Library, including input on sustainability. Mr. Berkman also clarified that the Parks and Recreation Board was asked by staff to make recommendation on materials at Brace Canyon Park, but a decision on final product will be made by City Council on December 6, 2022.

IV. APPROVAL OF MINUTES

The October 17, 2022, minutes were approved by Ms. Valdez, Ms. Deahl, Mr. Bennett, Ms. Kirschenbaum, Ms. Gemmill and Ms. Schanberger, noting Mr. Weber's absence. Ms. Zimskind and Mr. O'Brien abstained.

V. BRACE CANYON PARK PROJECT PRESENTATION

A consultant for the Parks and Recreation department, Ravi Bajaj, presented an overview of the turf replacement alternative life cycle analysis study, which evaluates three options for the field at Brace Canyon Park Ballfield using the impact categories of environment, human health, and community. Ms. Schanberger motioned to write a letter of support for the Parks and Recreation Boards recommendation for either option # 1 or option #3 of the Brace Canyon Park Ballfield Life Cycle Assessment and Triple Bottom Line Analysis and support the Vice Chair to speak for the Commission at the City Council meeting. The motion passed with Ms. Zimskind and Mr. Bennett abstaining, noting the absence of Mr. Weber.

VI. LETTER OF SUPPORT FOR EXPANSION OF SOCIAL MEDIA PLATFORM DISCUSSION Ms. Valdez shared the draft letter with the Commission. Jonathan Jones from the Public Information Office shared the City's social media policy, clarifying that the Public Works Director has the authority to expand the Commission's social media platform. Mr. Berkman said he will consider the request and communicate with the other Department executives and the City Manager.

5. CONSENT CALENDAR

- b. COMMISSION MINUTES. A draft copy of the November 21, 2022, Commission meeting minutes is attached for the Commission's review and approval.
- c. AWARD OF PROFESSIONAL SERVICES AGREEMENT FOR AIRPORT CARBON ACCREDITATION. A staff report is included in the agenda packet. At its meeting held on November 21, 2022, the Legal, Government and Environmental Affairs Committee voted unanimously (3–0) to recommend that the Commission award a Professional Services Agreement to Polytechnique Environmental, Inc., for a Level 2 Airport Carbon Accreditation certification from Airports Council International, to support the Authority with its sustainability efforts in reducing the carbon emissions footprint of Hollywood Burbank Airport through a Carbon Management Plan. The proposed Agreement has a not-to-exceed amount of \$34,720 for a one year-base period, with four one-year options capped in the amounts of \$19,810, \$23,310, \$19,810 and \$23,310 respectively for each option year, if exercised.
- d. AWARD OF PROFESSIONAL SERVICES AGREEMENT BOND AND DISCLOSURE COUNSEL SERVICES – REPLACEMENT PASSENGER TERMINAL. A staff report is included in the agenda packet. At its meeting held on December 7, 2022, the Executive Committee voted unanimously (3–0) to recommend that the Commission award a Professional Services Agreement to Orrick Herrington Sutcliffe LP to provide Bond and Disclosure Counsel services in support of the financing program for the development of the Replacement Passenger Terminal project at Hollywood Burbank Airport.
- e. AGENDA ITEM PROTOCOL. A staff report is included in the agenda packet. Staff seeks the Commission's adoption of an updated Resolution No. 496 to establish an agenda item protocol for items submitted to the Commission or a Committee.

- b. AWARD OF REPLACEMENT PASSENGER TERMINAL DESIGN-BUILD AGREEMENT IMPLEMENTING A PROJECT STUDIED IN A PREVIOUSLY CERTIFIED ENVIRONMENTAL IMPACT REPORT. A staff report is included in the agenda packet. At its meeting held on December 7, 2022, the Executive Committee voted unanimously (3–0) to recommend that the Commission: (i) award a Design-Build Agreement to Holder, Pankow, TEC, Joint Venture ("HPTJV") for the Replacement Passenger Terminal Project pursuant to a previously certified Environmental Impact Report; (ii) authorize initial funding of \$55,000,000 and (iii) authorize the issuance of a Notice to Proceed. HPTJV is comprised of Holder Construction Group, LLC, Charles Pankow Builders, Ltd., and TEC Management Consultants, Inc. d.b.a. TEC Constructors & Engineers.
- c. REPLACEMENT PASSENGER TERMINAL PROGRAM MANAGER JACOBS PROJECT MANAGEMENT COMPANY TASK ORDER AUTHORIZATION. A staff report is included in the agenda packet. At its meeting held on December 7, 2022, the Executive Committee voted unanimously (3–0) to recommend that the Commission approve Task Order #3 in the amount of \$10,438,765 with Jacobs Project Management Co. for program management services for the Replacement Passenger Terminal project.
