**SUBJECT:** Transportation Commission Meeting Synopsis – July 17, 2023

- Transportation staff presented the final design plans of Phase One of the San Fernando Boulevard Reconfiguration Project, which will reconfigure San Fernando Boulevard to one-way northbound vehicle operation between Olive Avenue and Magnolia Boulevard.
- The Commission provided the following feedback and suggestions on the project:
  - Discuss the newly constructed open spaces with the Art in Public Places Committee to beautify the project. Commissioners also noted that while the project is a pilot, when implemented it should look as if it were permanent.
  - Keep both aesthetics and safety in mind in designing the Olive Avenue entrance to San Fernando Boulevard, particularly regarding large planters that may or may not be installed throughout the project area.
  - The Commission raised concerns over the cost of more permanent fixtures and the need to balance the aesthetics with cost considerations.
  - Install a "Bikes May Use Full Lane" sign at the Olive Avenue entrance.
  - Request data more frequently from the Police Department to improve staff's analysis of the success of the project.
  - o More bike racks should be made available, if possible.
  - The flexible loading and parking spaces.
- The Commission also inquired about the metrics that staff will use to evaluate the project. Staff indicated that the following metrics would be considered:
  - Levels of service for San Fernando Boulevard and nearby intersections
  - o Crosswalk and yield compliance
  - Occurrences of illegal parking
  - o Crash data
  - Observational crosswalk data
  - Interviews with businesses and customers
- The Commission requested an update after implementation. Staff indicated the Commission would hear an update after six months of implementation.

**SUBJECT:** Transportation Commission Meeting Synopsis – August 21, 2023

- Eleven Burbank residents, and Commissioner Ehrhardt, speaking as a member of the public, voiced their opposition to the proposed Bob Hope Drive bicycle bridge over the Los Angeles River.
- Commissioner Lewis was elected Chair of the Commission. Commissioner Kalauskas was elected Vice Chair.
- Staff led a discussion on the pedestrian safety improvements identified for the Magnolia Park neighborhood that are included in the City's Complete Our Streets Plan. Staff reviewed two projects included in the Plan. The first is the Magnolia Boulevard Reconfiguration Project Phase 1 which is a mid-term (3-5 year) project to add four signalized intersections to all existing non-signalized intersections on Magnolia Boulevard between Catalina Street and Hollywood Way. The second is the Magnolia Boulevard Reconfiguration Project Phase 2 which is a long-term (20-year) project to reconfigure Magnolia Boulevard between Catalina Street and Hollywood Way to provide one travel lane in each direction and installation of median angled parking. Neither project is currently planned or funded. The Commission's discussion touched on:
  - How the proposed Noho-Pasadena BRT might divert traffic to Magnolia and if that might affect the viability of Phase 2 of the Magnolia pedestrian improvements.
  - How to better manage both traffic and pedestrians at the intersection of Magnolia and Hollywood Way, and possible public private partnerships to manage the high parking demand at that corner.
  - Potential funding sources for these projects.
  - Potential scramble or pedestrian only crosswalks.
  - A ban on right turns on red lights at certain intersections.
- Staff led a discussion on the City's curb parking management policies and programs for how curb parking spaces are managed in the City. The Commission discussed parking minimums, how installation of bike lanes conflict with parking, and employee parking in residential permit zones.
