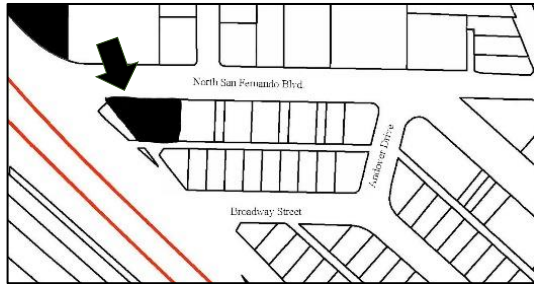
Why am I getting this?
