#### **TERMS AND CONDITIONS**

- 1. Only those residential dwelling units on a street block, within the posted street signs, are eligible to receive parking permits.
- Permits are not transferrable and must be affixed to lower-left, driver-side windshield.
- 3. Permits must be displayed properly to avoid citation.
- 4. Permit Issuance: 1 permit per CA DMV vehicle registration, up to a maximum of five (with vehicle registrations). No Exceptions.
- 5. Vehicle must be registered to your qualifying residential address to receive a permit.
- 6. All other posted restrictions (e.g. street sweeping, red curb, etc.) are enforceable, and must be obeyed.
- 7. Applicant agrees to comply with all requirements set forth by the City, including any changes subsequent to permit issuance.
- 8. Applicant is responsible for all permits issued. Permits may be revoked for failure to comply with the terms and conditions.
- 9. It is unlawful to sell, rent, or lease any permit for any value or consideration.
- 10. Replacement permits are \$30.00 each, and count toward the 5-permit per household, per permit cycle maximum.

# VISITOR PERMIT

### **TERMS AND CONDITIONS**

- 1. Visitor permit is valid during the current three-year permit period or portion thereof. Current permit period: 2018-2020.
- 2. Only those residential dwelling units on a street block, within the posted street signs, who have received/purchased at least one permit-only parking permit are eligible to receive one (1) visitor permit.
- 3. Permits must be displayed properly to avoid citation.
- 4. Permit issuance: ONE (1) visitor permit will be issued during the current three-year permit period.
- 5. All other posted restrictions (e.g. street sweeping, red curb, etc.) are enforceable, and must be obeyed.
- 6. Applicant agrees to comply with all requirements set by the City, including any changes subsequent to permit issuance.
- 7. Applicant is responsible for all permits issued. Permits may be revoked for failure to comply with the terms and conditions.
- 8. It is unlawful to sell, rent, or lease any permit for any value or consideration.
- 9. Permits must be displayed on vehicle registered to an address other than an address in the permit-only zone to avoid citation.
- 10. No more than ONE (1) replacement visitor permit will be issued. Replacement permits are \$30.00 each
