

City of Burbank <u>COMMERCIAL APPLICATION TO INSTALL</u> <u>NEW PARKING RESTRICTION</u>

Procedure

- 1. The *Application Criteria* listed on this page must be circulated along with the petition to <u>no less than</u> <u>80%</u> of the total businesses within a proposed zone.
- 2. The petition must demonstrate (via signatures) that at least 66% of the total businesses within the proposed zone support the proposed parking signs requested (only one adult signature per business).
- 3. The petition sponsor must sign the perjury statement on each page of the petition before submitting it to the Public Works Department.

<u>Criteria</u>

- 1. The petition must demonstrate, via signatures, the minimum 80% contact requirement has been met.
- 2. The petition must demonstrate, via signatures, the minimum 66% support requirement has been met.

Process

Petition signatures must be verified to determine that minimum contact and support requirements have been met.

- Petitions failing to meet the minimum contact/support requirements cannot be considered, and will be returned to the petition sponsor for additional signatures as necessary.
- Petition sponsor will be notified of the determination.
