### **ISSUED ON MARCH 8, 2021**

IT IS HEREBY ORDERED that the Temporary Restraining Order issued by this Court on March 8, 2021 (the "TRO") is hereby amended to add the following paragraph(s) to the TRO:

- 1. The Court authorizes the City, through its department and utility, Burbank Water on no less than and Power, to disconnect electrical service at Tin Horn Flats within 24 hours of NOTICE. TO COUNSEL FOR TIN HORN FLATS. signing the Order; and/or
- 2. The Court authorizes the City to padlock the doors to Tin Horn Flats until Barfly,
  Inc. obtains all valid and legally required permits to operate Tin Horn Flats.

  All other terms of the TRO issued by this Court on March 8, 2021 remain unchanged.
