City of Burbank Public Works Field Services NOTICE OF INTENT TO REMOVE GRAFFITI

This notice is to inform you that the City of Burbank has received a report of graffiti from that portion of your property which fronts on the public alley and/or sidewalk area.

It has been found that the most effective deterrent to graffiti is the prompt removal of the graffiti. One gang or group sees the graffiti performed by another gang or group and they retaliate by placing their own logo, symbol or phrase near the first graffiti. By promptly removing the graffiti, the number and frequency of retaliatory acts are diminished.

The City of Burbank will be glad to have additional graffiti removed from the interior of your property, at city expense, if you wish this work to be done. In order for the city to remove graffiti from surfaces inside your property, it is necessary that you sign and return to the city the release form at the bottom of this card.

The City of Burbank desires to do as complete and professional a job as is possible in removing graffiti and, to that end, we utilize several methods of removal:

Sandblasting - On non-painted surfaces such as block walls Solvents - Where practical Painting - Color-matched as closely as possible

If you do **NOT** want the City of Burbank to remove the graffiti from the surfaces of your property/building which front on public right-of-way, please contact the Public Works Field Services Office at **(818)** 238-3800 upon receiving this notice.

If you do not contract Public Works Field Services to decline graffiti removal, the city will remove the graffiti from that portion of your property which fronts on public right-of-way.
