My contributions to this school can be seen from the growth of its screenwriting dept to the multiple artistic, athletic and cultural clubs I helped launch to provide a more complete student experience. Between NYFA, my Temple and other involvements, I'm often planning one event or another, including the annual Purim Carnival at our Temple. Previous events included a Film and Music Festival in LA for my undergrad, music supervising a TED TALK in Manhattan Beach, Casino Night Fundraisers and Open Houses at NYFA. I also became a host / interviewer for numerous events and entertainment industry guests. My interview subjects have included SNL's Molly Shannon, Ed Begley Jr, and Academy Award-nominated producer Michael Shamberg. This led to my writing and producing THE BACKLOT PODCAST, which utilizes NYFA's massive library of Q&As and new interviews to help educate while (hopefully) entertaining. I have worked for years to create work - and to help others with their own creative work - that can reach and speak to an audience. As you may have seen, I'm not afraid of wielding a microphone as needed to help us all work together for the common good.

I'm proud of the work we (and it's a definite WE) did on the commission. Nine commissioners from such a wide spectrum of creative and artistic backgrounds working together to foster and empower our creative community. And at some point, to see more artistic venues populate the media capital ! Four years ago, I wrote "Am I allowed to admit the pride I feel seeing the Handy Market in "Twin Peaks" or Marty McFly skate past the Burger King on Victory in "Back to the Future?") " The answer is of course - yes. It's also the pride I feel when seeing dozens of students sharing their work at the Betsy Lueke or when so many people checked out of our virtual event about filming yourself better at home. There's so much great creative work done here - and still so much more we as a commission can do. I hope to be part of that on-going journey.
