

RESOLUTION NO. 15-28,741

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
BURBANK DECLARING THE RESULTS OF THE PRIMARY  
NOMINATING ELECTION HELD ON FEBRUARY 24, 2015.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

A. A Primary Nominating Election was conducted in the City of Burbank on Tuesday, February 24, 2015, for the purpose of nominating or electing candidates, for the terms of four years, to the following elective offices of the City:

1. Two offices of Council Member, succeeding Council Members Gary Bric and Emily Gabel-Luddy, whose terms expire April 30, 2015; and,
2. Three offices of Member of the Board of Education succeeding Board Member Ted Bunch, Dave Kemp and Roberta Grande Reynolds, whose terms expire on April 30, 2015.

B. It appears to the Council that notice of said Election was duly given, precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the Primary Nominating Election was conducted in the manner required by law.

C. The City Clerk has certified the canvass of said Election returns, duly posted the results, and received no protests.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

1. A Primary Nominating Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, February 24, 2015, in the time, form and manner required by law.

2. The regular election precincts established for holding the last general statewide election were consolidated into 29 precincts numbered Precincts 1 through 194 for the conduct of said election, as provided in Resolution No. 14-28,714 adopted October 7, 2014.

3. A total of 10,190 ballots were cast in said Election.


4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.

5. No candidates received more than a majority of the votes of the voters voting for such office at said Election for the office of Member of the City Council; and, is therefore the following four candidates who received the highest number of votes for Member of the City Council were duly and regularly nominated for said office; Juan J. Guillen Jr., Will Rogers, Emily Gabel-Luddy and Christopher John Rizotti. Their names shall be the names and the only names printed and the only names printed on the ballot as candidates for said office at the General Municipal Election to be held on April 4, 2015.


6. Two candidates received a majority of the votes of the voters voting for such office at said Election for the Office of Member of the Board of Education and as such, Steven Ferguson and Roberta Grande Reynolds, are declared to be elected to such offices for a full term of four years. The following two candidates who received the highest number of votes for Member of the Board of Education were duly and regularly nominated for said office; Dr. Armond Aghakhanian and Gregory Sousa. Their names shall be the names and the only names printed on the ballot as candidates for said office at the General Municipal Election to be held on April 14, 2015.

7. The City Clerk is directed to enter the Election results of the Primary Nominating Election in the minutes of the Council, administer the oaths of office and present certificates of election in accordance with the City Charter and Sections 2-3-2117, 2-3-2118 and 2-3-2119 of the Elections Code of the City of Burbank.
