RESOLUTION NO. 15-28,760

A RESOLUTION OF THE COUNCIL OF THE CITY OF BURBANK DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 14, 2015.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

A. A General Municipal Election was conducted in the City of Burbank on Tuesday, April 14, 2015, for the purpose of electing candidates, for the terms of four years, to the following elective offices of the City:

- Two offices of Council Member, succeeding Council Members Gary Bric and Emily Gabel-Luddy, whose terms expire April 30, 2015; and,
- 2. One office of Member of the Board of Education succeeding Board Member Ted Bunch, Dave Kemp and Roberta Grande Reynolds (two seats were filled in the Primary Nominating Election held on February 24, 2015), whose terms expire on April 30, 2015.

B. It appears to the Council that notice of said Election was duly given, precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the General Municipal Election was conducted in the manner required by law.

C. The City Clerk has certified the canvass of said Election returns, duly posted the results, and received no protests.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

1. A General Municipal Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, April 14, 2015, in the time, form and manner required by law.

2. The regular election precincts established for holding the last general statewide election were consolidated into 29 precincts numbered Precincts 1 through 194 for the conduct of said election, as provided in Resolution No. 14-28,714 adopted October 7, 2014.

3. A total of 11,032 ballots were cast in said Election.

4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.

5. Will Rogers and Emily Gabel-Luddy were the candidates receiving the highest number of votes for the Office of Member of the City Council and are declared to be duly and regularly elected to said office for a full term of four years.

6. Armond Aghakhanian was the candidate receiving the highest number of votes for the Office of Member of the Board of Education and is declared to be duly and regularly elected to said office for a full term of four years.

7. The City Clerk is directed to enter the Election results of the General Municipal Election in the minutes of the Council, administer the oaths of office and present certificates of election in accordance with the City Charter and Sections 2-3-2117, 2-3-2118 and 2-3-2119 of the Elections Code of the City of Burbank.
