

RESOLUTION NO. 17-28,915

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
BURBANK DECLARING THE RESULTS OF THE PRIMARY  
NOMINATING ELECTION HELD ON FEBRUARY 28, 2017.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

A. A Primary Nominating Election was conducted in the City of Burbank on Tuesday, February 28, 2017, for the purpose of nominating or electing candidates, for the terms of four years, to the following elective offices of the City:

1. Three offices of Council Member, succeeding Council Members Jess Talamantes, Robert "Bob" Frutos, and David Gordon, whose terms expire April 30, 2017; and,
2. One Office of the City Clerk, succeeding City Clerk Zizette Mullins, whose term expires April 30, 2017; and,
3. One Office of the City Treasurer, succeeding City Treasurer Debbie Kukta, whose term expires April 30, 2017; and,
4. Two offices of Member of the Board of Education succeeding Board Member Charlene "Char" Tabet, and Larry Applebaum, whose terms expire on April 30, 2017.

B. It appears to the Council that notice of said Election was duly given, precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the Primary Nominating Election was conducted in the manner required by law.

C. The City Clerk has certified the canvass of said Election returns, duly posted the results, and received no protests.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

1. A Primary Nominating Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, February 28, 2017, in the time, form and manner required by law.
2. The regular election precincts established for holding the last general statewide election were consolidated into 29 precincts numbered Precincts 1 through 180 for the conduct of said election, as provided in Resolution No. 16-28,893, adopted September 27, 2016.
3. A total of 10,902 ballots were cast in said Election.

4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast, are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.
5. One candidate, Jess A. Talamantes, received a majority of the votes cast at said Election for the office of Member of the City Council, and is therefore declared to be duly and regularly elected to said office for a full term of four years, ending on April 30, 2021.
6. No other candidates received more than a majority of the votes of the voters voting for such office at said Election for the office of Member of the City Council, and therefore the following four candidates who received the highest number of votes for Member of the City Council were duly and regularly nominated for said office: Robert "Bob" Frutos, Sharon Springer, Juan Guillen, and David Gordon. Their names shall be the names and the only names printed on the ballot as candidates for said office at the General Municipal Election to be held on Tuesday, April 11, 2017.
7. One candidate, Zizette Mullins, received a majority of the votes cast at said Election for the office of City Clerk, and is therefore declared to be duly and regularly elected to said office for a full term of four years, ending on April 30, 2021.
8. One candidate, Debbie Kukta, received a majority of the votes cast at said Election for the office of City Treasurer, and is therefore declared to be duly and regularly elected to said office for a full term of four years, ending on April 30, 2021.
9. Two candidates, Steven Frintner, and Charlene "Char" Tabet received more than a majority of the votes of the voters voting for such office at said Election for the office of Member of the Board of Education, and are therefore declared to be duly and regularly elected to said office for a full term of four years, ending on April 30, 2021.
10. The City Clerk is directed to enter the Election results of the Primary Nominating Election in the minutes of the Council, administer the oaths of office and present certificates of election in accordance with the City Charter and Sections 2-3-2117, 2-3-2118 and 2-3-2119 of the Elections Code of the City of Burbank.


