

RESOLUTION NO. 18-29,050

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURBANK, CALIFORNIA, RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION CONSOLIDATED WITH THE GENERAL ELECTION HELD IN SAID CITY ON TUESDAY, NOVEMBER 6, 2018, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a Special Municipal Election was consolidated with the General Election held and conducted in the City of Burbank, California, on Tuesday, November 6, 2018, as required by law; and

WHEREAS, the City Council of the City of Burbank, California, by Ordinance No. 18-3,905 and Resolution No. 18-29,029, adopted on July 17, 2018, did cause to be noticed to the qualified electors of the City, a Special Municipal Election to be held in the City of Burbank on the 6th day of November, 2018, for the purpose of a ballot measure as follows:

<u>Measure P - Burbank Infrastructure and Community Services Protection</u>	Yes	No
MEASURE P. To maintain City of Burbank's fire, police, 9-1-1 response; keep fire stations open; maintain the number of police/firefighters; repair streets/potholes; ease traffic; earthquake retrofit city buildings/bridges; maintain senior/after-school programs; address homelessness, other services and aging infrastructure; Shall the measure be adopted approving an ordinance establishing a 3/4¢ sales tax providing approximately \$20,000,000 annually until ended by voters; requiring audits, citizens' oversight, all funds used in Burbank?	<hr/>	<hr/>

WHEREAS, the notice of the election was given in time, form and manner as prescribed by law; the voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Burbank Charter, Municipal Code and where applicable Elections Code of the State of California, for the holding of elections; and

WHEREAS, the City's vendor, the Registrar of Voters of the County of Los Angeles, has canvassed the returns of the election and has certified the results as attached hereto made a part hereof as "Attachment A."

THE CITY COUNCIL OF THE CITY OF BURBANK RESOLVES:

Section 1. That the whole number of registered voters in the City was 65,428, making a total of 42,533 ballots cast in the City.

Section 2. That the ballot measure was presented as

- Measure P - Burbank Infrastructure and Community Services Protection

Section 3. Based on the 65,428 eligible Burbank Registered Voters, a total of 42,533 Ballots Cast, received and canvassed as required by law. The votes cast represent a 65.01% percent voter turnout rate. Of those ballots cast the following results in favor/opposing the measure:

Ballot Measure P – Burbank Infrastructure and Community Services Protection

Votes cast in favor "Yes": 24,567 (61.79%)

Votes cast in opposition "No": 15,190 (38.21%)

Total Ballots Cast: 42,533

That the number of votes given at each precinct and the number of votes given in the City to the measure are listed in "Attachment A"

Section 4. The City Council does declare and determine that:


Ballot Measure P – Burbank Infrastructure and Community Services Protection has passed.

2. The measure voted upon.

4. The number of votes given in the city for and against each measure.

Section 6. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.


