A RESOLUTION OF THE COUNCIL OF THE CITY OF BURBANK DECLARING THE RESULTS OF THE PRIMARY NOMINATING ELECTION HELD ON FEBRUARY 27, 2001.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

- A. A Primary Nominating Election was conducted in the City of Burbank on Tuesday, February 27, 2001, for the purpose of nominating or electing candidates, for the terms of four years, to the following elective offices of the City:
 - 1. Three offices of Member of the Council, succeeding Council Members Dave Golonski, Stacey Murphy and Bill Wiggins, whose terms expire April 30, 2001;
 - One office of City Clerk, succeeding City Clerk Judie Sarquiz, whose term expires April 30, 2001;
 - One office of City Treasurer, succeeding City Treasurer Jim Rogers, whose term expires April 30, 2001;
 - 4. Two offices of Member of the Board of Education succeeding Board Members Patricia (Trish) Burnett and Connie Lackey, whose terms expire on April 30, 2001.
- B. It appears to the Council that notice of said Election was duly given, voting precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the Primary Nominating Election was conducted in the manner required by law.
- C. The City Clerk has certified the canvass of said Election returns, duly posted the results, and received no protests.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

- 1. A Primary Nominating Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, February 27, 2001, in the time, form and manner required by law.
- 2. The regular election precincts established for holding the last general statewide election were consolidated into 42 precincts numbered Precincts 1 through 197 for the conduct of said election, as provided in Resolution No. 25,860 adopted October 24, 2000.
- 3. A total of 10,909 votes were cast in said Election consisting of 7,395 votes by electors present and voting, and 3,514 votes by absentee voters.
- 4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.
- 5. Stacey Murphy received a majority of the votes cast for all candidates for nomination to Member of the Council and is declared to be duly and regularly elected to said office for a full term of four years.
- 6. Dave Golonski, Gary Olson, Marsha Ramos and Howard Rothenbach were the four candidates receiving the highest number of votes for Member of the Council and were duly and regularly nominated for said office. Their names shall be the names and the only names printed on the ballot as candidates for said office at the General Municipal Election to be held on April 10, 2001.
- 7. Judie Sarquiz received a majority of the votes cast for all candidates for nomination to the Office of the City Clerk and is declared to be duly and regularly elected to said office for a full term of four years.
- 8. Donna Anderson received a majority of the votes cast for all candidates for nomination to the Office of the City Treasurer and is declared to be duly and regularly elected to said office for a full term of four years.
- 9. Patricia (Trish) Burnett and Connie Lackey were the two candidates receiving a majority of the votes cast for all candidates for nomination to Member of the Board of Education and are declared to be duly and regularly elected to said office for a full term of four years.
