A RESOLUTION OF THE COUNCIL OF THE CITY OF BURBANK DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 10, 2001.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

- A. A General Municipal Election and Special Municipal Election was conducted in the City of Burbank on Tuesday, April 10, 2001, for the purpose of electing two candidates for the term of four years, to the following elective offices of the City, to nominate or elect three candidates to the following elective offices of the Los Angeles Community College District, and to submit to the electors of the City the following two City measures and a Los Angeles Community College District Bond Proposition:
- 1. Two offices of Member of the Council, succeeding Council Members Bill Wiggins and Dave Golonski, whose terms expire April 30, 2001;
- 2. One office of Member of the Board of Trustees, Los Angeles Community College District, Office No. 2;
- 3. One office of Member of the Board of Trustees, Los Angeles Community College District, Office No. 4;
- 4. One office of Member of the Board of Trustees, Los Angeles Community College District, Office No. 6;
 - 5. Measure 1 Increase in City Council Member Compensation;
 - 6. Measure 2 Charter Amendment;
- 7. Proposition A Community College Facilities Construction and Repair Bond Program.
- B. It appears to the Council that notice of said Election was duly given, voting precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the General Municipal Election was conducted in the manner required by law.
- C. The City Clerk has certified the canvass of said Election returns, duly posted the results and received no protests.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

- 1. A General Municipal Election and Special Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, April 10, 2001, in the time, form and manner required by law.
- 2. The regular election precincts established for holding the last general statewide election were consolidated into 42 Precincts, 1 through 197 for the conduct of said election, as provided in Resolution No. 25,860, adopted October 24, 2000.
- 3. A total of 11,165 votes were cast in said Election consisting of 7626 votes by electors present and voting, and 3539 votes by absentee voters.
- 4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast, and the votes cast on Measures 1 and 2 are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.
- 5. Dave Golonski and Marsha Ramos were the two candidates receiving the highest number of votes for Member of the Council and are declared to be duly and regularly elected to said office for a full term of four years.
- 6. Measure 1, Increase in City Council Member Compensation, was approved by the voters and is declared to be effective. The total number of votes for Measure 1 was 5019 and the total number of votes against Measure 1 was 4651.
- 7. Measure 2, Charter Amendment, was approved by the voters and is declared to be effective. The total number of votes for Measure 2 was 5835 and the total number of votes against Measure 2 was 3508.
- 8. The City Clerk is directed to enter the Election results of the General Municipal Election and Special Municipal Election in the minutes of the Council, administer the oaths of office and present certificates of election in accordance with the City Charter and Sections 11-2117, 11-2118 and 11-2119 of the Elections Code of the City of Burbank.
