

A RESOLUTION OF THE COUNCIL OF THE CITY OF
BURBANK DECLARING THE RESULTS OF THE
PRIMARY NOMINATING ELECTION AND SPECIAL
ELECTIONS HELD ON FEBRUARY 25, 2003.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

A. A Primary Nominating Election was conducted in the City of Burbank on Tuesday, February 25, 2003, for the purpose of nominating or electing candidates, for the terms of four years, to the following elective offices of the City:

1. Two offices of Council Member, succeeding Council Members David Laurell and Jef Vander Borcht, whose terms expire April 30, 2003;
2. Three offices of Member of the Board of Education succeeding Board Members Mike McDonald, Elena Hubbell and Richard Raad, whose terms expire on April 30, 2003.

B. Consolidated with the Primary Nominating Election were special elections for voter consideration of Measure L, the Library Improvement Bond, and Measure M, the Advisory Vote on Mail Ballot Elections.

C. It appears to the Council that notice of said Election was duly given, voting precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the Primary Nominating Election was conducted in the manner required by law.

D. The City Clerk has certified the canvass of said Election returns, duly posted the results, and received no protests.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

1. A Primary Nominating Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, February 25, 2003, in the time, form and manner required by law.

2. The regular election precincts established for holding the last general

statewide election were consolidated into 42 precincts numbered Precincts 1 through 197 for the conduct of said election, as provided in Resolution No. 25,860 adopted October 24, 2000.

3. A total of 10,259 votes were cast in said Election consisting of 6,462 votes by electors present and voting, and 3,797 votes by absentee voters.

4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.

5. No Candidate received a majority of the votes cast for the two City Council seats. Gary R. Bric, Todd Campbell, Brian Malone and Jef Vander Borcht are the four candidates who received the highest number of votes for Member of the Council and were duly and regularly nominated for said office. Their names shall be the only names printed on the ballot as candidates for said office at the General Municipal Election to be held on April 8, 2003.

6. Dave L. Kemp was the only candidate to receive a majority of the votes cast for Member of the Board of Education and is declared to be duly and regularly elected to said office for a full term of four years. Larry Applebaum, Ted Bunch, Paul Krekorian, and Mike McDonald are the four candidates who received the highest number of votes for Member of the Board of Education and were duly and regularly nominated for said office. Their names shall be the only names printed on the ballot as candidates for the remaining two seats for said office at the General Municipal Election to be held on April 8, 2003.

7. Measure L, the Library Improvement Bond, received 67.9 percent of the votes cast, achieving the required two-thirds voter approval.

8. Measure M, the advisory vote on all Mail Ballot Elections, received 63.6 percent of the votes cast on the measure.


