

RESOLUTION NO. 27,164

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
BURBANK DECLARING THE RESULTS OF THE  
SPECIAL ELECTION HELD ON JANUARY 24, 2006.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

A. A Special Election was conducted in the City of Burbank on Tuesday, January 24, 2006, for the purpose of filling a vacancy for the following elective offices of the City:

1. One office of Council Member, replacing Council Member Stacey Murphy, who resigned on August 30, 2005 with a term expiring on April 30, 2009.

B. It appears to the Council that notice of said Election was duly given, precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the Special Election was conducted in the manner required by law.

C. The City Clerk has certified the canvass of said Election returns, duly posted the results, and received no protests.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

1. A Special Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, January 24, 2006, in the time, form and manner required by law.

2. The regular election precincts established for holding the last general statewide election were consolidated into 42 precincts numbered Precincts 2 through 197 for the conduct of said election, as provided in Resolution No. 27,073 adopted on September 27, 2005.


3. A total of 11,399 votes were cast in said Election.

4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.


5. David Gordon received the highest number of votes cast for Member of the City Council and is duly and regularly elected to said office to fill an unexpired term ending April 30, 2009.

6. The City Clerk is directed to enter the Election results of the Special Election in the minutes of the Council, administer the oaths of office and present certificates of election in accordance with the City Charter and Sections 11-2117, 11-2118 and 11-2119 of the Elections Code of the City of Burbank.




