

RESOLUTION NO. 27,873

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
BURBANK DECLARING THE RESULTS OF THE  
PRIMARY NOMINATING ELECTION HELD ON  
FEBRUARY 24, 2009.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

A. A Primary Nominating Election was conducted in the City of Burbank on Tuesday, February 24, 2009, for the purpose of nominating or electing candidates, for the terms of four years, to the following elective offices of the City:

1. Three offices of Council Member, succeeding Council Members Dave Golonski, David Gordon and Marsha Ramos, whose terms expire April 30, 2009;
2. Two offices of Member of the Board of Education succeeding Board Members Larry Applebaum and Debbie Kukta, whose terms expire on April 30, 2009;
3. One office of City Clerk, succeeding City Clerk Margarita Campos, whose term expires on April 30, 2009; and,
4. One office of City Treasurer, succeeding City Treasurer Donna E. Anderson, whose term expires on April 30, 2009.

B. It appears to the Council that notice of said Election was duly given, precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the Primary Nominating Election was conducted in the manner required by law

C. The City Clerk has certified the canvass of said Election returns, duly posted the results, and received no protests.


THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

1. A Primary Nominating Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, February 24, 2009, in the time, form and manner required by law.

2. The regular election precincts established for holding the last general statewide election were consolidated into 42 precincts numbered Precincts 1 through 193 for the conduct of said election, as provided in Resolution No. 27,789 adopted October 14, 2008.


3. A total of 10,990 votes were cast in said Election.
4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.
5. No candidate received a majority of the votes cast at said Election for the Office of Member of the City Council and as such, the following six candidates who received the highest number of votes for Member of the Council were duly and regularly nominated for said office; Dave Golonski; David Gordon; Jess Talamantes; Kimberly Jo; Elise Stearns-Niesen; and, Garen Yegparian. Their names shall be the names and the only names printed on the ballot as candidates for said office at the General Municipal Election to be held on April 14, 2009.
6. Two candidates for the offices of Member of the Board of Education (Debbie Kukta and Larry Applebaum) received a majority of the votes cast at said Election and are therefore declared to be duly and regularly elected to said office for a full term of four years. These offices will not be on the ballot for the General Municipal Election to be held on April 14, 2009.
7. Margarita Campos received a majority of the votes cast for the Office of City Clerk and is declared to be duly and regularly elected to said office for a full term of four years. This office will not be on the ballot for the General Municipal Election to be held on April 14, 2009.
8. Donna E Anderson received a majority of the votes cast for the Office of City Treasurer and is declared to be duly and regularly elected to said office for a full term of four years. This office will not be on the ballot for the General Municipal Election to be held on April 14, 2009.
9. The City Clerk is directed to enter the Election results of the Primary Nominating Election in the minutes of the Council, administer the oaths of office and present certificates of election in accordance with the City Charter and Sections 2-3-2117, 2-3-2118 and 2-3-2119 of the Elections Code of the City of Burbank.


