

RESOLUTION NO. 28,325

A RESOLUTION OF THE COUNCIL OF THE CITY OF
BURBANK DECLARING THE RESULTS OF THE GENERAL
MUNICIPAL AND SPECIAL ELECTIONS HELD ON APRIL
12, 2011.

THE COUNCIL OF THE CITY OF BURBANK FINDS:

A. Consolidated General Municipal and Special Elections were conducted in the City of Burbank on Tuesday, April 12, 2011, for the purpose of electing one candidate, for the term of four years, to the following elective office of the City and to submit to the electors of the City of Burbank the following measure:

1. One office of Council Member, succeeding Council Member Anja Reinke, whose term expires April 30, 2011;
2. Measure U – Modernize Utility Users Tax Ordinance.

B. It appears to the Council that notice of said Election was duly given, precincts were duly established, election officers were duly appointed, election supplies were furnished, the votes cast in said Election were received and canvassed by the City Clerk in the time, form and manner required by law, and in all respects the General Municipal and Special Elections were conducted in the manner required by law.

C. The City Clerk has certified the canvass of said Election returns, duly posted the results, and received one protest which was withdrawn.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

1. A consolidated General Municipal and Special Election was conducted in the City of Burbank, County of Los Angeles, State of California, on Tuesday, April 12, 2011, in the time, form and manner required by law.

2. The regular election precincts established for holding the last general statewide election were consolidated into 42 precincts numbered Precincts 1 through 193 for the conduct of said election, as provided in Resolution No. 28,212 adopted September 28, 2010.

3. A total of 8,866 votes were cast in said Election.


4. The number of votes cast in each precinct and the names of the persons voted for and the office for which the votes were cast are shown in the summary of the City Clerk which is marked "Exhibit A" attached hereto.

5. Emily Gabel-Luddy was the candidate receiving the highest number of votes for the Office of Member of the City Council and is declared to be duly and regularly elected to said office for a full term of four years.


6. Measure U, Modernize Utility Users Tax Ordinance, was approved by the voters and will go into effect. The total number of votes cast in favor of Measure U was 5,270 and the total number of votes cast against Measure U was 2,562.

7. The City Clerk is directed to enter the results of the General Municipal and Special Elections in the minutes of the Council, administer the Oaths of Office and present Certificates of Election in accordance with the City Charter and Sections 2-3-2117, 2-3-2118 and 2-3-2119 of the Elections Code of the City of Burbank.




