City of Burbank Investment Portfolio Report for August 2019 Dated September 20, 2019

This report fulfills City, Youth Endowment Services Fund, Parking Authority, Public Financing Authority, Successor Agency to the Redevelopment Agency and Housing Authority resolutions.

CITY PORTFOLIO OVERVIEW

The City must maintain \$87 million in liquidity at all times (maturities within one year plus real estate taxes due from the County in April and December) to meet our projected budgeted expenditures. We currently have \$186 million in liquidity, with \$65 million in our account at the Local Agency Investment Fund (LAIF), \$78 million in investments maturing within a year and \$43 million in real estate taxes due in April and December. Higher liquidity levels continue to be maintained in anticipation of future cash outflows.

The City Investment Pool ended August at \$431 million, up from July's balance of \$427 million. Market value increased from 100.18% in July to 100.77% in August. The yield for August came in at 2.13%, with the fiscal year-to-date yield coming in at 2.13%. The weighted average yield of the portfolio at the end of the month is 2.13%.

MARKET OUTLOOK

On September 18, the Federal Reserve cut interest rates by 25 basis points for the second straight month to a target range between 1.75% and 2%. Federal Reserve chair Jerome Powell explained that the decision was made "to help keep the U.S. economy strong in the face of some notable

developments and to provide insurance against ongoing risks." Even with low unemployment and strong consumer spending, business capital investments have weakened due to global economic uncertainty.

It has been a volatile month for Treasuries with the 30-year yield hitting an all-time low below 2% in August. The benchmark 10-year yield also came close to its all-time closing low. While rates have recovered since then, dissenting perspectives from hawkish and dovish members of the Fed suggest continuing uncertainty in future monetary policy and interest rate movements.




Chart 1: 5-year Treasury Yields, September 20, 2018 through September 20, 2019 Source: Bloomberg


City of Burbank Distribution by Asset Category - Market Value





The chart to the left shows relevant rates (LAIF, the 12-month moving average of the 2-year treasury, and portfolio current yield) as of August 31, 2019, as well as current treasury yields and those from a year ago.

The portfolio yield is slowly catching up to the benchmark but still lagging as a result of the buildup in liquidity to meet cash flow requirements, causing a significant decline in the portfolio's duration, and the quick rise of short term interest rates.

NOTE: Estimates for the interest earned on LAIF's loan to CaIPERS (not allocated until just after the end of each quarter) are included in this month's LAIF yield. The effective rate of return published by LAIF for August was 2.34%; including the bonus accrual for the loan to CaIPERS of .10%, the yield reflected on the books for August is 2.44%. The rate of interest charged by LAIF on the CaIPERS loan is the Constant Maturity 2-Year Treasury as of the last day of the quarter.
