A RESOLUTION OF THE COUNCIL OF THE CITY OF
BURBANK ADOPTING THE FISCAL YEAR 2025-2026
CITYWIDE FEE SCHEDULE

THE COUNCIL OF THE CITY OF BURBANK FINDS:

A. Section 1-1-112 of the Burbank Municipal Code provides that all fees, penalties, and charges of any kind levied by the City shall be designated in the Burbank Fee Resolution (commonly referred to as the Citywide Fee Schedule), as amended by the Council from time to time.

B. At a regular meeting held on May 20, 2025, the City Council adopted Resolution No. 25-29,610 approving certain amendments to fees and charges for water, refuse, sewer, and electric services, and directed that such fees and charges be included in the proposed Fiscal Year 2025-2026 and Fiscal Year 2026-2027 Citywide Fee Schedule to be presented to the City Council for approval and adoption on June 3, 2025.

C. The proposed Fiscal Year 2025-2026 Citywide Fee Schedule incorporating the aforementioned amendments to fees and charges for water, refuse, sewer, and electric services along with other proposed amendments to the schedules, tables, fees, taxes, penalties, and charges set forth in the current Citywide Fee Schedule was presented to the City Council for approval and adoption on June 3, 2025.

D. Pursuant to Government Code §66016, as of May 1, 2025, as part of the proposed budget book, the data indicating the amount of cost, or estimated cost, required to provide the service for which a fee or service charge is levied or increased and the revenue sources anticipated to provide the service, including General Fund revenues, was available to the public.

THE COUNCIL OF THE CITY OF BURBANK RESOLVES:

1. That the Fiscal Year 2025-2026 Citywide Fee Schedule, including the amendments to the schedules, tables, fees, taxes, penalties, and charges noted in the "Fee Schedule Changes" section of the Proposed Budget document submitted in support of this Resolution and a Resolution of the Council of the City of Burbank Approving Increases to Fees and Charges for Water, Sewer, and Electric Services for Inclusion in the Fiscal Year 2025-2026 Citywide Fee Schedule that the City Council adopted on May 20, 2025, is hereby adopted.

2. That the intent of the City Council in adopting this Resolution is to incorporate the amended and revised fees and charges for various City services in the Fiscal Year 2025-2026 Citywide Fee Schedule and that all other fees and charges appearing therein shall continue in effect and shall not be deemed to have been repealed or readopted by this Resolution.
