City of Burbank Investment Portfolio Report for May 2025 **Dated July 2, 2025**

This report fulfills City, Youth Endowment Services Fund, Parking Authority, Public Financing Authority, Successor Agency to the Redevelopment Agency and Housing Authority resolutions.

CITY PORTFOLIO OVERVIEW

The City must maintain \$124 million in liquidity at all times (maturities within one year plus real estate taxes due from the County in April and December) to meet our projected budgeted expenditures. We currently have \$384 million in liquidity, with \$137 million in our account at the California Asset Management Program, \$88 million in LAIF, \$3 million in our account at the Morgan Stanley Institutional Liquidity Fund – Government Portfolio, \$105 million in investments maturing within a year and \$51 million in real estate taxes due in April and December.

The City Investment Pool ended May at \$723 million, up from April's balance of \$711 million. Market value came in at 99.3% in May, slightly down from 99.5% in April. The weighted average yield of the portfolio at cost at the end of the month is 3.48%.

Credit News

On July 1, Moody's affirmed Blackrock's ratings while changing its outlook from negative to stable, stating that it "reflects the progress it has made towards integrating Global Infrastructure Partners ("GIP", acquired October 2024) and Prequin (acquired March 2025), two significant acquisitions it undertook over the past year, as well as the strategic benefits and accretive financial effects of the all-stock acquisition of HPS. BlackRock is successfully raising investment advisory and performance fees sourced from alternative management, while accelerating growth of technology-based revenues. In considering the outcomes of this M&A activity, in combination with the strong organic growth of the company's standalone business over the past year and favorable market performance, we have grown increasingly confident that the company's leverage ratio will decline below our downgrade trigger of 1.5x upon close of the HPS transaction. BlackRock's Aa3 long-term senior debt and P-1 short-term ratings reflect the company's position as the world's largest asset manager with high earnings capacity, moderate financial leverage, strong and stable profitability, and a strong liquidity profile. The rating also reflects our view that BlackRock enjoys a strong competitive advantage over other asset managers, which it has augmented with high-profile acquisitions in the course of 2024. The stable outlook reflects our view that BlackRock's credit fundamentals and financial profile will remain consistent with its assigned rating."


On July 1, Moody's affirmed The Hershey Company's ratings while changing its outlook from stable to negative, stating that it "reflects our expectation that earnings will weaken over the next year due to high cocoa prices and tariffs. Cocoa prices more than doubled in 2024 and remain elevated and volatile. While the company's hedging strategy has delayed the full impact, hedges locked in at higher cocoa costs are expected to significantly reduce profitability in 2025. Additionally, the company is likely to face further earnings pressure from tariffs, primarily related to cocoa imports and retaliatory tariffs from Canada on chocolate. Hershey estimates the unmitigated tariff impact could be up to \$100 million per quarter in both the third and fourth quarters. Hershey intends to mitigate cocoa pressure through pricing, price-pack architecture, and operational efficiencies over time, and is pursuing an exemption for cocoa tariffs. While pricing is expected to be a primary lever, it poses risks of volume declines and potential market share erosion. Therefore, we expect a measured approach, using multiple strategies to support earnings. So far, volume elasticity from pricing has been lower than anticipated, highlighting the category's resilience. Still, confectionery volumes have declined, driven both by pricing actions and consumer cost-conscious spending."

MARKET OUTLOOK

The Federal Reserve continues its "wait and see" approach as officials unanimously voted to hold rates steady in their June meeting. The bank's official statement emphasized that the decision stems from the fact that "economic activity has continued to expand at a solid pace. The unemployment rate remains low, and labor market conditions remain solid. Inflation remains somewhat elevated." While most committee members believe the Fed will cut rates twice later this year, some members also believe that the Fed may not cut rates at all. Stagflation remains a risk which could happen if economic growth slows down, unemployment increases, and inflation picks back up. In its latest projections, the Fed now predicts GDP to slow down to 1.4% this year, consumer prices to increase 3%, and unemployment to increase slightly to 4.5%.

While most European countries have already cut their rates as they face weak economic growth and low inflation, the economic outlook in the US is still unclear. The S&P has regained all its losses and recently hit record highs as investors now believe the business-friendly administration would not let the stock market drop too far. While inflation has ticked up slightly with the Personal Consumption Expenditures (PCE) price index slightly higher at 2.3% in May, the impacts of the tariffs remain muted and prices have remained relatively stable. However, economists believe the price impact of tariffs are just delayed as it takes a while for price increases to work their way into the supply chain. Most companies have stockpiled inventory and have tried to absorb the price increases as much as they can, but will likely pass on higher prices to customers later this year, especially if it seems likely that tariffs will remain in the long run. Tariff negotiations are still ongoing so it is uncertain where prices will be even a few months from now. The US dollar has continued to weaken with the currency now down over 10% since the start of the year, as there is eroding confidence in the role of the US as a safe haven in the global financial system. While oil prices are currently relatively low, it is also unclear where they will go in the future, especially with the political turmoil in the Middle East. Meanwhile, the job market continues to remain solid with the latest job openings number exceeding forecasts in May and layoffs declining at the same time. While most of the vacancies are in the leisure and hospitality sectors, other industries like finance, healthcare, and transportation also saw modest gains. However, the job market has been uneven with new college graduates seeing higher unemployment rates, in some cases because companies are trying to replace entry-level jobs with artificial intelligence. In another sign of cracks in the labor market, the latest ADP jobs report showed that private payrolls lost 33,000 jobs in June, missing expectations, and the first decrease since March 2023.

Note: The actual target rate shows the midpoint of the federal funds target rate range. - Source: Federal Reserve - By Karl Russell



Percentage change in the U.S. dollar index in the first half of every year since 1986.




Distribution by Asset Category - Market Value



Portfolio Holdings as of 5/31/2025






