

NON-DISCRIMINATION POLICY STATEMENT

The City of Burbank is committed to ensuring compliance with Title VI of the Civil Rights Act of 1964 and other non-discriminatory authorities, such that no person shall be excluded from participation in or be denied the benefits of any program or activity conducted by the City of Burbank on the grounds of race, color, national origin, sex, age, disability, religion, sexual orientation, gender identity, or any other category protected by State or Federal law. Further, no person shall be subjected to discrimination under any program or activity conducted by the City of Burbank on the grounds of race, color, national origin, sex, age, disability, religion, sexual orientation, gender identity, or any other category protected by State or Federal law. Title VI compliance is a condition of receipt of federal funds, particularly the Federal Highway Administration (FHWA) funds.

Title VI staff in the Community Development Department is authorized to ensure compliance with this policy, Title VI of the Civil Rights Act of 1964, 42 U.S.C § 2000d and related statutes, and the requirements of 23 Code of Federal Regulation (CFR) pt. 200 and 49 CFR pt. 21.

The Title VI Implementation Plan is available for the public ((23 CFR 200.9(b)(11 and 12)) and updated on an as-needed basis while the Goals and Accomplishment Report will be available every year (23 CFR 200.9(b)(10). 1. NON-DISCRIMINATORY LEGISLATION

Below is a list of nondiscriminatory legislation.

- Title VI of the Civil Rights Act of 1964 Provides that no person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination, under any program or activity receiving Federal financial assistance (as implemented through 23 CFR 200.9 and 49 CFR 21).
- Section 162(a) of the Federal-Aid Highway Act of 1973 (Section 324, Title 23 U.S.C.) Prohibits discrimination on the basis of sex by recipients and subrecipients of Federal financial assistance.
- Section 504 of the Rehabilitation Act of 1973 Prohibits discrimination on the basis of disability by recipients and sub-recipients of Federal financial assistance.
- Executive Order 12898 (issued February 11, 1994) Addresses Environmental Justice regarding minority and low-income populations and requires agencies to develop strategies to address disproportionately high and adverse human health or environmental effects of their programs on minority and low-income populations; promote nondiscrimination in federal programs substantially affecting human health and the environment; and provide minority and low-income communities access to public information and an opportunity for public participation in matters relating to human health or the environment.
- Executive Order 13166 (issued August 16, 2000) Addresses improved access
 to services for persons with limited English proficiency. Agencies are directed
 to evaluate services provided and implement a system that ensures that Limited
 English Proficiency (LEP) persons are able to meaningfully access the services
 provided consistent with, and without unduly burdening, the fundamental
 mission of the local agency. Agencies are directed to ensure that recipients of
 federal financial assistance provide meaningful access to program, services and
 information to their LEP.
- The Age Discrimination Act of 1975 (Section 6101-6107, Title 42 U.S.C.) –
 Prohibits discrimination on the basis of age by recipients and sub-recipients or Federal financial assistance.
- The Civil Rights Restoration Act of 1987 (Public Law 200-209) Clarifies that the original intent of Congress in Title VI of the Civil Rights Act of 1964, Title IX of the Educational Amendments of 1972, the Age Discrimination Act of 1975, and Section 504 of the Rehabilitation Act of 1973 was to apply the non-discrimination statutes to all programs and activities of Federal aid recipients, sub-recipients, contractors and vendors, whether all such programs are federally assisted or not.

2. ORGANIZATION CHART

Title VI is managed by the Community Development Department. Below are assigned roles for Title VI.

TITLE VI COORDINATOR (Community Development Director)

- Ensures that City's Title VI is updated with all requirements set forth by the FHWA, Caltrans, and any other applicable jurisdictions.
- Communicates with City Manager and City leadership positions to facilitate the Title VI Program requirements.
- Directs staff to draft Title VI Plan, draft annual reports, coordinate trainings, prepare required reports, create and distribute Title VI information for the public (including other required languages), and manage complaints.
- Assists program personnel to correct Title VI problems or discriminatory practices or policies found through self-monitoring.
- Ensures that Title VI requirements are included in policy directives and that the procedures used have built-in safeguards to prevent discrimination.
- Note: Title VI Coordinator contact information is disseminated to the public (23 CFR 200.9(b)(1)

- Prepares Title VI Plan (including complaint procedures) and Annual Report submissions.
- Develops Title VI information for dissemination to public.
- Ensures that Title VI Assurances have been incorporated into all federal-funded agreements.
- Develops procedures for collection and analysis of statistical data of participants in, and beneficiaries of federally funded roadway projects.
- Analyzes data collected to determine effectiveness of outreach methods to avoid group exclusion, and encourage group participation.

TITLE VI LIASION (Transportation Services Manager)

- Works directly with contractors, public stakeholders and other relevant parties to ensure that Title VI protections are maintained.
- Develops and coordinates Title VI training for managers, supervisors and staff with frequent public contract, on a twoyear minimum basis.
- Reports complaints through complaint procedure listed as part of City's Title VI Implementation Program Plan.
- Disseminates Title VI information to the public, including other identified languages.
- Drafts the Title VI Plan and Annual Report submissions.

3. COMPLAINT PROCEDURE

Any person that believes they been discriminated against on the grounds of race, color, national origin, sex, age, disability, religion, sexual orientation, gender identity, or any other category protected by State or Federal law, the public, its contractors, consultants or any other party may file a Title VI complaint by completing the City's Title VI Complaint Form (23 CFR 200.9(b)(3). There are three (3) steps in filing a complaint:



LOCATE COMPLAINT FORM

Locate the complaint form. The complaint form is attached to this plan (Attachment 1), online at (https://www.burbankca.gov/web/community-development/titlevi), and available at the Community Services Building located at 150 N. Third Street, 2nd floor, Burbank, CA 91502.

The complaint form is in English, Spanish, and Armenian.

COMPLETE THE COMPLAINT FORM

Complete the form. The City will only process complaints that are complete, which include at a minimum, the following:

- A. Contact information
- B. Date of alleged act of discrimination
- C. Details of the alleged discrimination
- D. The complainant's signature

SUBMIT FORM WITHIN 180 CALENDAR DAYS

All complaints must be written and submitted within 180 calendar days from the alleged incident. Forms are to be submitted to one of the following:

The FHWA Guidance Memorandum, Processing of Title VI Complaints (June 13, 2018) states that all Title VI complaints received by a sub-recipient, City of Burbank, are to be forwarded to Caltrans to be submitted to FHWA Division Office. Complaints should be sent within **one (1) business day** of receipt via email to Title.VI@dot.ca.gov. If Headquarters Office of Civil Rights (HCR) determines a Title VI complaint against a sub-recipient can be investigated by Caltrans, HCR may delegate the task of investigating the complaint to Caltrans.

Should a complaint be filed with Burbank Community Development Department and one with a federal or state agency simultaneously, the federal/state complaint will supersede the City's complaint and the City's complaint procedures will be suspended pending the federal/state agency's findings.

4. DATA COLLECTION, LIMITED ENGLISH PROFICIENCY (LEP) ANALYSIS, AND LEP PLAN

The Four Factor Analysis

The Four Factor Analysis is used to determine the specific language services that are appropriate to provide to ensure meaningful access to programs and activities. This detailed analysis helps to determine the effectiveness of communication with Limited English Proficiency (LEP) persons and informs language access planning. The Four Factors and the associated steps included are:

Factor 1: The Number or Proportion of LEP Persons Eligible to Be Served or Likely to Be Encountered by the Program or Recipient

Data from the U.S. Census Bureau was used to determine demographic data for the population living in the City of Burbank. Table 1 shows minority census tracts within the City.

Spanish and Armenian are the two top primary languages spoken in Burbank other than English. Spanish speakers who speak English "less than very well" account for nearly 7,000 persons or just under seven percent of the total population, while Armenian speakers who speak English "less than very well" comprise of nearly 6,000 persons or almost six percent (6%) of the population in the City of Burbank.

If more than five percent of the sub-recipient's population in its service area has LEP, Title VI information must be translated into the applicable language of that population. Therefore, the City of Burbank is required to provide translations for Spanish and Armenian.



Table 2 summarizes census information on the LEP populations in the City of Burbank. In the City of Burbank, over 17,400 residents or nearly 18 percent of the population report that they speak English "less than very well." Other languages identified through U.S. Census data are Korean and Arabic. Individuals that speak Korean and Arabic and speak English "less than very well" are below the 5 percent (5%) threshold.

Factor 2: The Frequency with Which LEP Individuals Come into Contact with the Program

The City of Burbank is a full-service city that has its own Police Department, Fire Department, Parks and Recreation Department, trash services/landfill, and public utilities for its residents and businesses. Due to the variety of City services and program, the City anticipates that people from various backgrounds participate every day. There is no specific data and statistics collected based on LEP individuals due to the amount of services provided. However, the City is equipped to assist the population at any City facility, program, and services with translation services.

Factor 3: The Nature and Importance of the Program, Activity, or Service Provided to People's Lives.

There are very few to no requests for translation services on federally funded projects and activities. However, translation services are requested for other City services such building permits, public works permits, plan check, Section 8, utility payments, and City programs. Staff is aware of the Title VI Implementation Plan and the Census data provided in this Title VI Implementation Plan that provides information on the local population in Burbank. Due to the diverse background in Burbank, public notices and City website are translated into Spanish and Armenian to ensure compliance and easy, visible access to the LEP population.

Factor 4: The Resources Available to the Recipient for LEP Outreach and Associated Costs

Limited Assistance Plan

Individuals who have a limited ability to read, write, speak or understand English are Limited English Proficient or "LEP". This Language Assistance Plan implements Federal policy guidance regarding responsibilities to Limited English Proficient persons, Executive Order 13166 and Federal Register Vol. 70, No. 239.

Translation Services: The City of Burbank identifies a list of City staff that speak languages other than English, and have been designated for translations services to the public. This list of staff is updated every month and those that have been identified has been screened on their ability to communicate, read, and/or write in a specific language. As of June 2024, there are more than 240 City staff readily available to translate in Arabic, Armenian, Chinese, Faroese, French, Korean, Persian-Iranian, Russian, Serbo-Croatian, Spanish, Tagalog, and Vietnamese. Translation is provided to the public at any City facility location.

Publications and services are available for LEP to view include:

- Title VI Complaint Form
- I Speak Cards
- Title VI Webpage
- Future public notices for federally-funded projects

In order to ensure that Title VI and related Civil Rights information is readily available to the public, the City has public notices consisting of posters, flyers, complaint forms and "I Speak" cards that are available in English, Spanish, and Armenian. Public notices regarding Title VI are placed in several highly visible and accessible location such as:

Dissemination of Title VI information to the public is required, per 23 CFR 200.9(b)(12).

5. TRAINING

Title VI training is provided to managers, supervisors, and staff with frequent public contact in the administration of federal-aid programs (23 CFR 200.9(b)(9)). These trainings will occur at minimum every two years, and within six months of hiring a new employee. The trainings will be conducted by the Title VI Specialist or Liaison, online or in-person. Additionally, links to Caltrans, FHWA, and other applicable agency resources for Title VI and related statutes will be posted on the City's website for reference and easy access.

The following topics will be covered in trainings:

- Review of the Burbank's Title VI Implementation Plan and other relevant documents.
- Review of assurances related to contracts.
- Language assistance services and "I Speak Cards" offered for public use.
- Process for potential Title VI complaints.
- Where to seek assistance for Title VI questions and concerns.



6. CONTRACT DOCUMENTS AND AGREEMENTS

The City will ensure that any federally-funded project documents contain the necessary Title VI Assurances. Such assurances include, but may not be limited to:

- o FHWA Form 1273 (Title VI and other non-discriminatory requirements) (Link)
 - Required on all FHWA contracts and subcontracts valued greater than \$10,000
 - Note: The most updated FHWA Form is dated October 23, 2023.

During the performance of a contract that is federally funded, the contractor, for itself, its assignees, and successors in interest (hereinafter referred to as the "contractor") agrees as follows:

Solicitation for Subcontracts, Including Procurements of Materials and Equipment: In all solicitations, either by competitive bidding, or negotiation made by the contractor for work to be performed under a subcontract, including procurements of materials, or leases of equipment, each potential subcontractor or supplier will be notified by the contractor of the contractor's obligations under this contract and the Acts and the Regulations relative to Non-discrimination on the grounds of race, color, national origin, age, sex, or disability.
- 4. Information and Reports: The contractor will provide all information and reports required by the Acts, the Regulations, and directives issued pursuant thereto and will permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the Recipient or the FHWA to be pertinent to ascertain compliance with such Acts, Regulations, and instructions. Where any information required of a contractor is in the exclusive possession of another who fails or refuses to furnish the information, the contractor will so certify to the Recipient or the FHWA, as appropriate, and will set forth what efforts it has made to obtain the information.
- 5. Sanctions for Noncompliance: In the event of a contractor's noncompliance with the Non-discrimination provisions of this contract, the Recipient will impose such contract sanctions as it or the FHWA may determine to be appropriate, including, but not limited to:
 - 1. withholding payments to the contractor under the contract until the contractor complies; and/or

- 2. cancelling, terminating, or suspending a contract, in whole or in part.
- 6. Incorporation of Provisions: The contractor will include the provisions of paragraphs one through six in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Acts, the Regulations and directives issued pursuant thereto. The contractor will take action with respect to any subcontract or procurement as the Recipient or the FHWA may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, that if the contractor becomes involved in, or threatened with litigation by a subcontractor, or supplier because of such direction, the contractor may request the Recipient to enter into any litigation to protect the interests of the Recipient. In addition, the contractor may request the United States to enter into the litigation to protect the interests of the United States.

APPENDIX B CLAUSES FOR DEEDS TRANSFERRING UNITED STATES PROPERTY

The following clauses will be included in deeds effecting or recording the transfer of real property, structures, or improvements thereon, or granting interest therein from the United States pursuant to the provisions of Assurance 4:

NOW THEREFORE, the U.S. Department of Transportation as authorized by law and upon the condition that the California Department of Transportation will accept title to the lands and maintain the project constructed thereon in accordance with Title 23 U.S.C., the regulations for the administration of the preceding statute, and the policies and procedures prescribed by the FHWA of the U.S. Department of Transportation in accordance and in compliance with all requirements imposed by Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Non-discrimination in Federally-assisted programs of the U.S. Department of Transportation pertaining to and effectuating the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252; 42 U.S.C. § 2000d to 2000d-4), does hereby remise, release, quitclaim and convey unto the California Department of Transportation all the right, title and interest of the U.S. Department of Transportation in and to said lands described in Exhibit A attached hereto and made a part hereof.

(HABENDUM CLAUSE)

TO HAVE AND TO HOLD said lands and interests therein unto the California Department of Transportation and its successors forever, subject, however, to the covenants, conditions, restrictions and reservations herein contained as follows, which will remain in effect for the period during which the real property or structures are used for a purpose for which Federal financial assistance is extended or for another purpose involving the provision of similar services or benefits and will be binding on the California Department of Transportation, its successors and assigns.

The California Department of Transportation, in consideration of the conveyance of said lands and interest in lands, does hereby covenant and agree as a covenant

running with the land for itself, its successors and assigns, that (1) no person will on the grounds of race, color, or national origin, be excluded from participation in be denied the benefits of, or be otherwise subjected to discrimination with regard to any facility located wholly or in part on, over, or under such lands hereby conveyed [.] [and]* (2) that the California Department of Transportation will use the lands and interests in lands and interest in lands so conveyed, in compliance with all requirements imposed by or pursuant to Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-assisted programs of the U.S. Department of Transportation, Effectuation of Title VI of the Civil Rights Act of 1964, and as said Regulations and Acts may be amended[, and (3) that in the event of breach of any of the above-mentioned non-discrimination conditions, the Department will have a right to enter or re-enter said lands and facilities on said lands, and that above described land and facilities will thereon revert to and vest in and become the absolute property of the U.S. Department of Transportation and its assigns as such interest existed prior to this instruction].*

APPENDIX C

In the event facilities are constructed, maintained, or otherwise operated on the property described in this (deed, license, lease, permit, etc.) for a purpose for which a U.S. Department of Transportation activity, facility, or program is extended or for another purpose involving the provision of similar services or benefits, the (grantee, licensee, lessee, permittee, etc.) will maintain and operate such facilities and services in compliance with all requirements imposed by the Acts and Regulations (as may be amended) such that no person on the grounds of race, color, or national origin, will be excluded from participation in, denied the benefits of, or be otherwise subjected to discrimination in the use of said facilities.
- B. With respect to licenses, leases, permits, etc., in the event of breach of any of the above Non-discrimination covenants, the California Department of Transportation will have the right to terminate the (lease, license, permit, etc.)

- and to enter, re-enter, and repossess said lands and facilities thereon, and hold the same as if the (lease, license, permit, etc.) had never been made or issued.*
